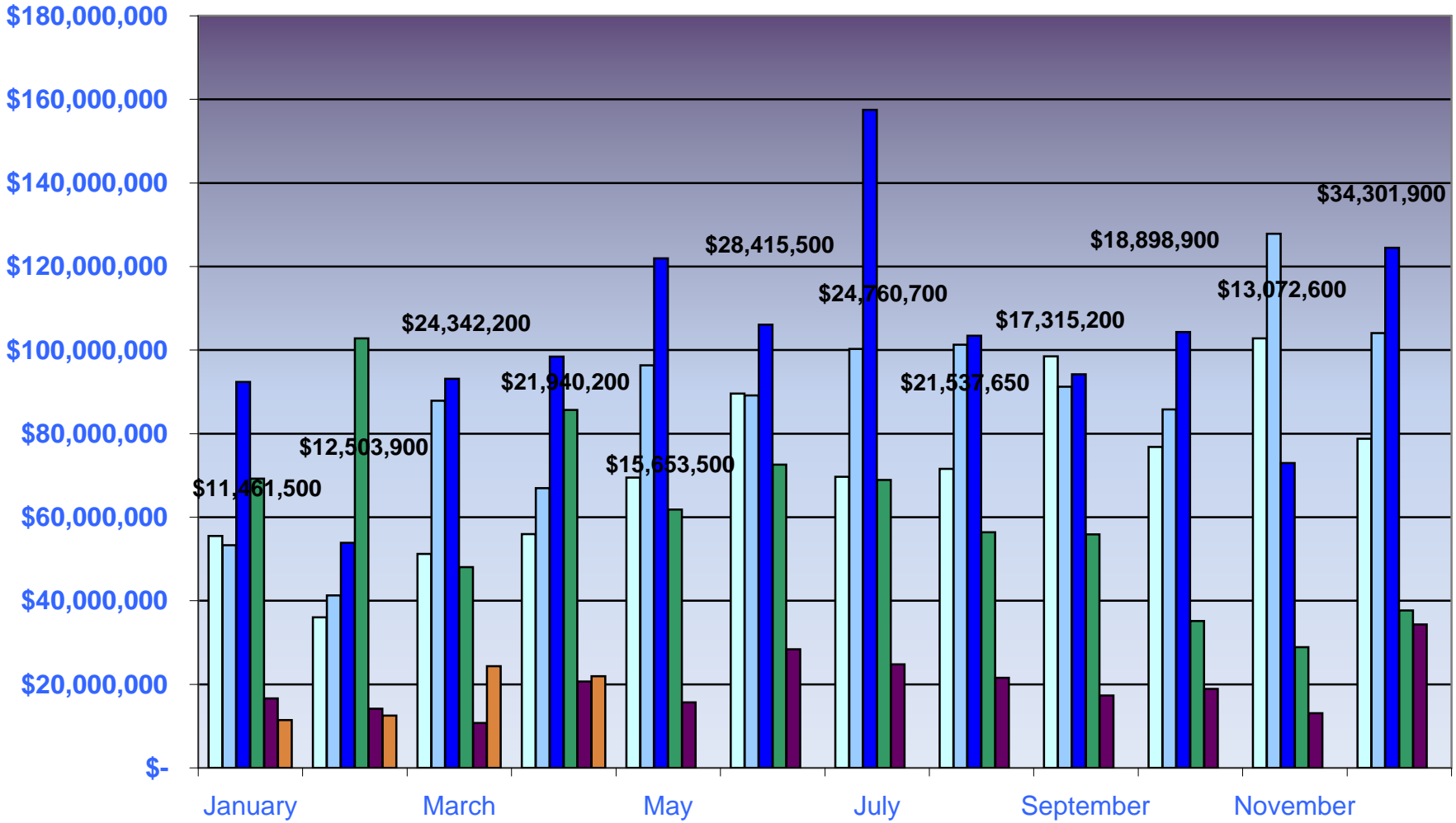

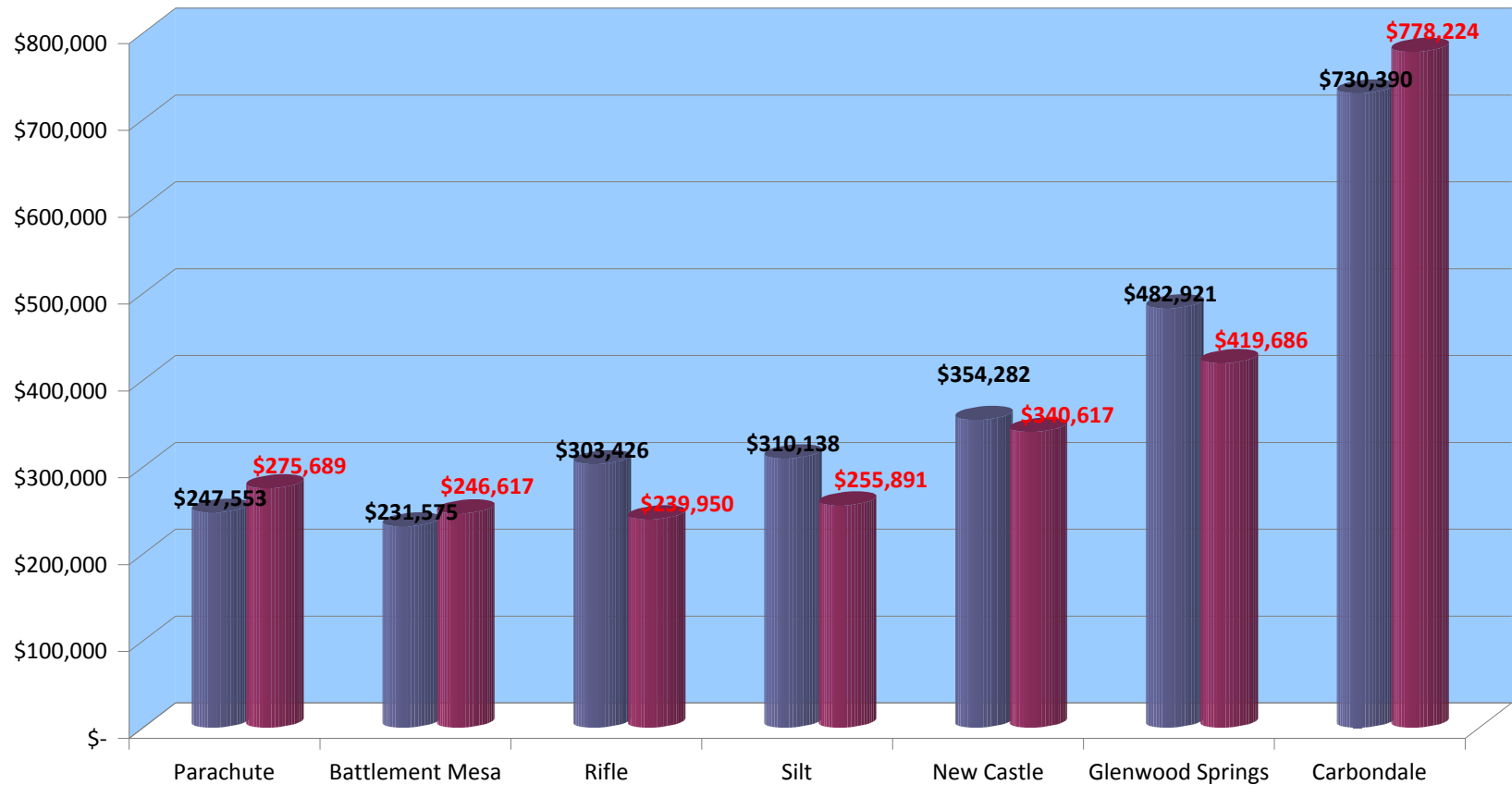

Full Year 2009 vs. YTD 2010: Average Multi-Family Price by Area



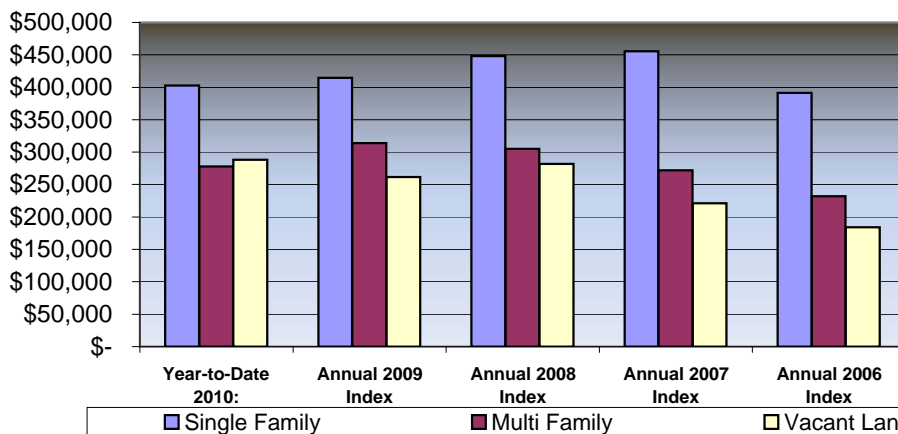

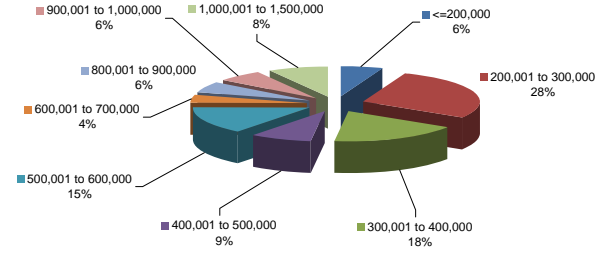

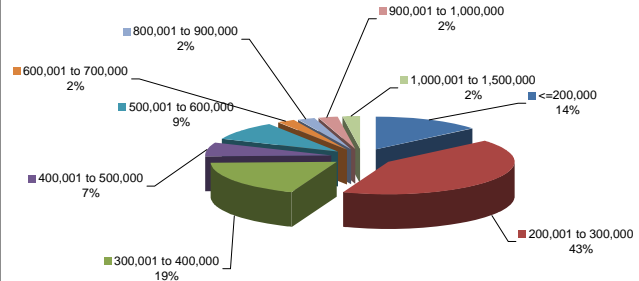
